CABRC 2026 Doctoral Colloquium and Workshop

- A Doctoral Colloquium is scheduled for research (MPhil, DBA and PHD) students on May 25, 2026.
- Doctoral (or a higher degree research) student can get one-to-one feedback on their drafted paper(s) from the experts attending the conference or from an editor of an affiliated journal.
- A workshop will be conducted for young and early career researchers who will learn how to progress their research project and will get publication tips.

Other Benefits

- Certificate of Attendance:** All in-person registered delegates will receive a certificate of attendance.
- Best Paper Award:** Best Paper Awards (value USD300) and Best Student Paper Awards (value US\$200) from several tracks will be conferred at the conference. The authors of the best papers will also get certificates. To be eligible for this criteria, a full paper is to be registered for an in-person presentation.
- Online Abstract Proceedings:** Conference proceedings based on the accepted abstracts of the registered participants will be prepared and published online with ISBN 978-0-6459250-2-9, one week before the conference.


